

1. Information We Collect

We currently collect limited personal information.

Account Information

When you create an account, we may collect:

- Email address
- Authentication-related account identifiers
- Subscription or entitlement status, such as whether your account has access to paid features

We use Firebase Authentication to help create and manage user accounts.

Payment Information

Peptica uses Stripe to process payments and subscriptions. We do **not** directly collect, store, or process your full credit card number, debit card number, bank account information, or other complete payment credentials.

Stripe may collect and process payment information, billing details, transaction records, fraud-prevention data, and related information according to its own privacy practices. Stripe states that it processes personal data for services including payment processing, verification, and fraud prevention. Stripe may also retain transaction records where required by law or regulation.

Usage and Technical Information

We may automatically collect limited technical information necessary to operate and secure the website, such as:

- IP address
- Browser type
- Device type
- Operating system
- Log data
- Authentication session information
- Cookie or similar session identifiers

We do not currently use analytics services such as Google Analytics, Meta Pixel, TikTok Pixel, PostHog, Plausible, or similar third-party tracking tools. If this changes, we will update this Privacy Policy.

Information We Do Not Intentionally Collect

Peptica does not intentionally collect:

- Medical conditions
- Treatment history
- Medication usage
- Peptide usage
- Weight loss goals
- Health records
- GPS location
- Search history
- Saved vendor history
- Favorited vendors
- User reviews, ratings, or comments

Do not submit medical or health information to Peptica.

2. How We Use Information

We use collected information to:

- Create and manage user accounts
- Authenticate users
- Provide access to free or paid features
- Verify subscription entitlement
- Process subscriptions through Stripe
- Maintain website security
- Prevent fraud, abuse, or unauthorized access

- Respond to user support or deletion requests
- Comply with legal obligations
- Improve, maintain, and debug the service

We do not use your information to provide medical advice, healthcare recommendations, diagnosis, treatment, or prescribing services.

3. Payments and Subscriptions

Peptica may offer paid monthly subscription access. The final subscription price may be shown at checkout.

Payments are processed by Stripe. When you subscribe, Stripe may collect payment and billing information directly from you. Peptica receives limited payment-related information from Stripe, such as subscription status, customer identifiers, payment status, and entitlement-related information.

Peptica uses this information only to manage access to paid features.

Canceling a subscription may stop future billing, but Stripe may retain payment and transaction records as required by law, regulation, fraud prevention, accounting, tax compliance, or its own legal obligations.

4. Cookies and Similar Technologies

Peptica may use cookies, local storage, session tokens, or similar technologies for essential website functions, including:

Firebase Authentication and related infrastructure may use cookies or similar technologies to support authentication and security.

We may share limited information with service providers who help operate Peptica, including:

Firestore / Google

Used for account authentication and related security functions.

NeonDB

Used to store account-related service data, such as user identifiers, email addresses, and entitlement status.

Stripe

Used for payment processing, subscription management, fraud prevention, and billing-related services.

Legal or Safety Disclosures

We may disclose information if we believe it is necessary to:

- Comply with applicable law
 - Respond to lawful requests, subpoenas, or legal process
 - Enforce our Terms of Service
 - Protect the rights, safety, or security of Peptica, users, vendors, or others
 - Investigate fraud, abuse, or unauthorized access

6. Sale or Sharing of Personal Information

Peptica does **not currently sell personal information**.
