These Terms of Service (“Terms”) govern your access to and use of Peptica, including the website located at **peptica.tech** and any related services, pages, features, content, subscriptions, or tools offered by Peptica (“Peptica,” “we,” “us,” or “our”).

By accessing or using Peptica, creating an account, or purchasing a subscription, you agree to these Terms. If you do not agree, do not use Peptica.

Peptica is intended only for users located in the United States who are at least 18 years old.

1. What Peptica Is
